# **Dissemination of Corporate Communications**

Pursuant to new Rule 2.07A<sup>1</sup> of the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the articles of association of Jujiang Construction Group Co., Ltd. ### **ARRANGEMENTS**

# 1. Actionable Corporate Communications<sup>4</sup>

If the Company does not possess the email address of a H Shareholder or the email address provided is not functional<sup>5</sup>, the Company will send the Actionable Corporate Communication in printed form together with a request form for soliciting the H Shareholder's functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.

### 2. Corporate Communications

The Company will make the Corporate Communications available on its website (www.jujiang.cn) and the Stock Exchange's website (www.hkexnews.hk).

A notice of publication of the Website Version<sup>6</sup> of Corporate Communications, in both English and Chinese, will be sent by the Company to H Shareholders by email or by post (only if the Company does not possess the functional email address of a H Shareholder) on the publication date of the Corporate Communications.

# PROVISION OF H SHAREHOLDER'S EMAIL ADDRESS TO THE COMPANY
